



7. REPORTS AND DOCUMENTATION



- (a) Any breach of this Agreement by either party
- (b) Any negligence on the part of either party

9. NOTICES

All notices regarding this Agreement shall be by personal delivery or by certified or registered mail, postage prepaid, at the addresses as either of them may so provide by notice given to the other in the same manner.

10. GOVERNING LAW

This MOU is made under and shall be governed by and construed under the laws of the Republic of India under the jurisdiction of the courts at Chennai.


11. ARBITRATION

General Terms

Specific activities and programmes implemented under authority of this MoU shall be subject to availability of funds and the approval of each parties authorized representatives.

Prior to initiating any specific activity or programmes, the parties will negotiate and enter into a definite agreement, signed by each party's authorized signatory, describing the terms of the arrangement, including but not limited to financial commitments, academic freedom commitments, immigration and compliance obligation and details of the exchange or collaborative relationship. This MoU is not intended to create any legally binding obligation on either institution but it is included to facilitate discussions regarding general areas of cooperation.

Specific Terms

Student Exchange

4. Course credits and grades earned will be determined by the home institution based on the grade report from the host institution.

5. Participants may not spend more than one year normally in the exchange programme.

6. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations, if any, of the host country regarding foreign students studying in the host country.

Selection and Nomination

The selection and nomination of students is open throughout the academic year. The student nomination should be accompanied by:

- Curriculum Vitae.
- Statement of aptitude from a member of the student's school / faculty.
- A specific outline of the programme of study at the host institution and a statement of objectives of the student.

When a nomination is forwarded by the home institution, it is presumed that the sending institution considers the student suitable for the proposed programme and consents to send the student if selected by the host institution. The host institution will evaluate the nomination and determine their suitability for selection under the Student Exchange Programme.

Where the exchange student is pursuing a research or implementing a project as part of the degree programme, the host institution will provide a suitable faculty member to jointly assist (along with the supervisor in the parent institution) the exchange student in formulating research project or jointly supervising the exchange student in the event that a research project has already been identified.

The host institution will inform the home institution of any academic or other problems that may arise during the period of student's residence in the host institution. The host institution will take appropriate action under its established policy and procedures, in consultation with the home

Exchange of Faculty

1. Both institutions agree to encourage faculty and staff participation in exchange programme activities.
2. Applicants for participation in the exchange will be selected by the home institution and will be subject to acceptance by the host institution.
3. The period of exchange will be determined by the purpose of the exchange. The duration of the faculty and staff exchanges shall be arranged as appropriate and in accordance with the established rules and practices of the host institution.
4. The home institution will maintain their faculty/staff member on full salary and benefits for the period of exchange. The host institution will supply office space, library privileges, technology linkage, and other facilities appropriate to the position at the host institution.

6. All faculty and staff shall be covered by health, emergency evacuation and repatriation insurance that is valid in the host nation. The cost of insurance will be paid by the participants or their university, depending on the home university policy.
7. Exchange personnel are subject to the laws of the host country, to the rules and regulations of the host institution, and the cultural modes of the host nation.
8. This agreement pertains to exchange participants only, and does not include spouses or dependents.

Research Collaboration

Faculty from both Institutions will collaborate in the supervision of exchange students and in joint research in disciplines of mutual interest.

1. Proposals for collaborative research work under this Memorandum will be submitted with the prior approval of the Head of each institution, or his / her nominee.


- 8) Classes will be held under the department of Management Studies at Auxilium College (Autonomous).
- 9) Classes will be handled by faculty from Auxilium College (Autonomous) and Resource persons arranged by the Department of Hospital Management Studies & Staff Training and Development, CMC for hospital related subjects and few faculty from CMC (doctors, nurses and technicians) including retired medical professionals (doctors, nurses and technicians) from Vellore.
- 10) The classes will be held between 8.30 am to 1.30 pm on all working days.
- 11) B.B.A (Hospital Administration) course will be conducted under the Choice Based Credit System (CBCS) in accordance with which the syllabus will be framed by CMC and Auxilium College (Autonomous).
- 12) Duration of the B.B.A (Hospital Administration) course is 3 years with six semesters.
- 13) Examinations for B.B.A (Hospital Administration) students shall be conducted by the Controller of Examinations, Auxilium College (Autonomous). Valuation and Assessment of a student is based on two components: Continuous Assessment (CA) and Semester Examinations (SE).


A) Continuous Assessment (CA):

- i. The maximum marks for CA is 40.
- ii. Each written CA examination is for 50 marks and of two hours duration. The tests will be conducted centrally. The average of two such CA examinations is calculated for 35 marks.
- iii. Other Innovative Components will be for 5 Marks
 - a. The innovative component is conducted by the Staff member incharge of the subject, in the form of assignments/ quiz / seminars / presentations/ viva voce / group work / mini project / exhibition, etc. The topic and time for submission / presentation will be announced by the staff member incharge of the subject in advance. Each student should explain and defend her presentation.
- iv. A re-test for CA will be conducted for a student who is absent due to NSS/NCC/Sports or related activities on prior written permission obtained through the concerned staff member.
- v. There is no passing minimum for CA.
- vi. There is no provision for improvement in CA.

B) Semester Examinations (SE)

- i. The maximum marks for SE is 60.
- ii. The SE will be of 3 hours duration and for 100 marks which will be converted to 60.
- iii. A student should register for herself to appear for SE by payment of the prescribed examination fee.
- iv. The SE will be in the form of a comprehensive examination covering the entire syllabus in each subject. It will be of 3 hours duration, irrespective of the number of credits allotted to it.
- v. The maximum marks for each paper shall be 100.





- 14) As a part of the course curriculum, the students are expected to do an internship for 3 months in the 6th semester. During internship, B.B.A (Hospital Administration) students will be posted in various departments at CMC / other hospitals to acquire hands-on experience.
- 15) The degree shall be issued by Thiruvalluvar University, Vellore.
- 16) A Bachelor's degree shall be awarded only for those who have successfully completed the course which is determined based on their performance and clearance in SE.
- 17) The graduation for the B.B.A (Hospital Administration) students will be held at Auxilium College (Autonomous).

Finance

- 1) Course fees for the B.B.A (Hospital Administration) programme would be Rs.15,000/- (Rupees Fifteen Thousand only) per student per semester for the 1st year. From the 2nd year onwards, fees could be subject to upward revision. The fees will be revised as and when found necessary and also complying with the directions given by the Government.
- 2) Fee sharing from the course fee would be as follows:
 - a. There is a onetime payment (for 3 years) to the University as application fee of Rs.18,000/-; processing fee of Rs.24,000/-; and affiliation fee of Rs.1,20,000/- (Total Rs.1,62,000/-) which are to be shared 50% each. This onetime payment is per year for the first batch of the B.B.A (Hospital Administration) students i.e., 2017-2018, 2018-2019 & 2019-2020.
 - b. The fee sharing would be 50% for CMC Vellore and 50% for Auxilium College (Autonomous) after the deduction of processing fee payable to the University. The processing fee consists of admission fee, University fee, Development fee, Caution deposit, etc.,
 - c. Fee concessions for the economically under privileged students by Auxilium College (Autonomous) and CMC will be considered for a maximum of 8 students of the total intake of 70 students which is 11.4 %
The concession amount will be decided by the representatives of both the institutes and will be based on a case by case evaluation of the economically under privileged students seeking concession.
The quantum of concession could be up to a maximum payable by the student for the whole course, excluding University and Examination fees, which are mandatory.
Depending upon who is recommending the student (Auxilium College (Autonomous) / CMC) for the 8 seats, to that extent the amount from the sharable amount would be reduced for that institute.


- 3) The department of Hospital Management Studies & Staff Training & Development, CMC shall maintain a separate dedicated account (special fund) wherein the receipts and payment of the BBA (Hospital Administration) course would be maintained.

The parties believe that:

1. Mutual benefit can be derived from scholarly interaction, faculty exchange, and other forms of academic collaboration in related subjects and courses.
2. The parties regard the following areas of cooperation as desirable and feasible:
 - i. Exchange of academic staff members.

 - iv. Opportunities for other forms of cooperation, such as delivery of award and non-award courses.

3. The terms of specific areas of cooperation shall be further considered and agreed upon in writing by the parties prior to the initiation of any particular activity.
4. Any specific program will be subject to mutual consent, availability of funds and approval of both parties.
5. This agreement will be effective when both parties have signed this agreement and shall remain in force for a period of five years unless it is mutually agreed otherwise.

- 1) Selection of BBA (HA) candidates for 25% quota of CMC, Vellore, would be as per procedures laid down by CMC, Vellore.
- 2) The CMC fee component will be transferred to the designated special fund account of the department of Hospital Management Studies and Staff Training and Development specially opened for this programme, on or before 15th September and 15th March every year by Auxilium College (Autonomous).

- Collaboration in the conduct of National / International Conferences, Seminars, Workshops, Faculty Development Programmes and other Academic meetings

General Terms of Agreement

Specific activities and programme implemented under authority of this MoU shall be subject to availability of funds and the approval of each parties authorized representatives.

Prior to initiating any specific activity or programmes, the parties will negotiate and enter into a definite agreement, signed by each party's authorized signatory, describing the terms of the arrangement, including but not limited to financial commitments, academic freedom commitments, immigration and compliance obligation and details of the exchange or collaborative relationship. This MoU is not intended to create any legally binding obligation on either institution but it is included to facilitate discussions regarding general areas of cooperation.

Specific Terms

Student Exchange

1. Neither institution will require admission or tuition fees of exchange students under this MoU.
2. The duration of the exchange programme will be decided by both the institution.
3. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations.

Selection and Nomination

The selection and nomination of students is open throughout the academic year. The student nomination should be accompanied by:

- Curriculum Vitae.
- Statement of aptitude from a member of the student's school / faculty.
- A specific outline of the programme of study at the host institution and a statement of objectives of the student.

When a nomination is forwarded by the home institution, it is presumed that the sending institution considers the student suitable for the proposed programme and consents to send the student if selected by the host institution. The host institution will evaluate the nomination and determine their suitability for selection under the Student Exchange Programme.

Exchange of Faculty

1. Both institutions agree to encourage faculty and staff participation in exchange programme activities.
2. Applicants for participation in the exchange will be selected by the home institution and will be subject to acceptance by the host institution.
3. The period of exchange will be determined by the purpose of the exchange. The duration of the faculty and staff exchanges shall be arranged as appropriate and in accordance with the established rules and practices of the host institution.
4. The home institution will maintain their faculty/staff member on full salary and benefits for the period of exchange. The host institution will supply office space, library privileges, technology linkage, and other facilities appropriate to the position at the host institution.
5. This agreement pertains to exchange participants only, and does not include spouses or dependents.

Research Collaboration

Faculty from both Institutions will collaborate in the supervision of exchange students and in joint research in disciplines of mutual interest.

1. Proposals for collaborative research work under this Memorandum will be submitted with the prior approval of the Head of each institution, or his / her nominee.
2. Each institution will nominate one of its members as its representative in charge of the cooperative programme. Individual programmes of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.

3. Progress of work of any individual programme will be reviewed and approved by designated authorities of both parties.
4. The final approval of any project will depend on the availability of guaranteed support funds.
5. Every collaboration will have its own agreement / contract which addresses issues such as Intellectual Property Rights (under the legal rights of the constitutions of both the parties), funding pattern, disclosure of information etc.

Commencement, Renewal, Termination and Amendment

This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for three years. This MoU may be renewed upon its expiry, with the agreement of both partner institutions.

If either partner institution wishes to terminate the MoU at the end of the three years period it must notify the other institution not less than six months prior to the expiry of the MoU.



- Collaboration in the conduct of National / International Conferences, Seminars, Workshops, Faculty Development Programmes and other Academic meetings

General Terms of Agreement

Specific activities and programme implemented under authority of this MoU shall be subject to availability of funds and the approval of each parties authorized representatives.

Prior to initiating any specific activity or programmes, the parties will negotiate and enter into a definite agreement, signed by each party's authorized signatory, describing the terms of the arrangement, including but not limited to financial commitments, academic freedom commitments, immigration and compliance obligation and details of the exchange or collaborative relationship. This MoU is not intended to create any legally binding obligation on either institution but it is included to facilitate discussions regarding general areas of cooperation.

Specific Terms

Student Exchange

1. Neither institution will require admission or tuition fees of exchange students under this MoU.
2. The duration of the exchange programme will be decided by both the institution.
3. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations.

Selection and Nomination

The selection and nomination of students is open throughout the academic year. The student nomination should be accompanied by:

- Curriculum Vitae.
- Statement of aptitude from a member of the student's school / faculty.
- A specific outline of the programme of study at the host institution and a statement of objectives of the student.

When a nomination is forwarded by the home institution, it is presumed that the sending institution considers the student suitable for the proposed programme and consents to send the student if selected by the host institution. The host institution will evaluate the nomination and determine their suitability for selection under the Student Exchange Programme.

Exchange of Faculty

1. Both institutions agree to encourage faculty and staff participation in exchange programme activities.
2. Applicants for participation in the exchange will be selected by the home institution and will be subject to acceptance by the host institution.
3. The period of exchange will be determined by the purpose of the exchange. The duration of the faculty and staff exchanges shall be arranged as appropriate and in accordance with the established rules and practices of the host institution.
4. The home institution will maintain their faculty/staff member on full salary and benefits for the period of exchange. The host institution will supply office space, library privileges, technology linkage, and other facilities appropriate to the position at the host institution.
5. This agreement pertains to exchange participants only, and does not include spouses or dependents.

Research Collaboration

Faculty from both Institutions will collaborate in the supervision of exchange students and in joint research in disciplines of mutual interest.

1. Proposals for collaborative research work under this Memorandum will be submitted with the prior approval of the Head of each institution, or his / her nominee.
2. Each institution will nominate one of its members as its representative in charge of the cooperative programme. Individual programmes of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
3. Progress of work of any individual programme will be reviewed and approved by designated authorities of both parties.
4. The final approval of any project will depend on the availability of guaranteed support funds.
5. Neither Auxilium College and St. Joseph's College be held responsible for any liability to the other party, and neither party shall be required to purchase any insurance against loss or damage to any property due to activities to which this agreement relates.
6. Every collaboration will have its own agreement / contract which addresses issues such as Intellectual Property Rights (under the legal rights of the constitutions of both the parties), funding pattern, disclosure of information etc.

Commencement, Renewal, Termination and Amendment

This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for three years. This MoU may be renewed upon its expiry, with the agreement of both partner institutions.

If either partner institution wishes to terminate the MoU at the end of the three years period it must notify the other institution not less than six months prior to the expiry of the MoU.

This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or

extension to the agreement may be formalized by the exchange of letters between the two parties.
